In adherence to Legal decree 223/2006 converted to Law 248/2006 relating to the acquisition of fiscal codes by clients who purchase travel packages, we remind users that these details must be provided at the moment of booking. The detail that MUST be provided is that of the main passenger/client for the transaction, independently of the rest of the participants in the trip. Only in the case of co-heading of the bill to more than one subject is it obligatory to provide the fiscal codes of ALL THE MAIN CLIENTS. In order to make operations as efficient as possible, it is desirable, when booking, to have the details of all the participants in the trip at hand. The data requested by the above legislative decree will also be treated in adherence with the norms regarding the protection of personal data.
